#### 2024 HRA TAX LEVY AND STATE AFFORDABLE HOUSING AID

The board was agreeable to the possibility of decreasing the \$500,000 special levy to either \$340,000 or \$250,000 contingent upon the allocation of the \$160,409 from Clay County SAHA funds and \$85,000 from Moorhead SAHA funds.

#### HRA BOARD COMMISSIONER REPLACEMENT

The board will recommend Greg Lemke be appointed to the HRA board to the Clay County Commission. If the recommendation is accepted, the number of board members will remain at 4 with additional discussion at a later date.

A motion was made by Commissioner Braseth to recommend Greg Lemke to complete Commissioner Schlotfeldt's term on the Clay County HRA Board. Commissioner Johnson seconded the motion and it carried unanimously.
